EA1	Aircraft dedicated to search and rescue under the direction of the police or the department of National Defence
EA2	Aircraft dedicated to fire fighting and related operational training
EA3	Aircraft dedicated to air ambulance operations paid by the government
EA5*	Aircraft dedicated to operating for a registered charity as defined by the <i>Income Tax Act (Canada)</i> or foreign equivalent * In order for the Declaration Form to be processed, Charity Organizations must provide proof of their registration as a charitable organization. These documents must be accompanied by the completed Declaration Form.
EA6*	State aircraft of a foreign country, unless charging authorized by an Order-in-Council * "State aircraft" means an aircraft, other than an aircraft operated for commercial purposes, that is owned and operated by the government of a country or the government of a colony, dependency, province, state, territory or municipality of a country.
EA7	Aircraft operated under the authority of the Minister of National Defence
EA9	Aircraft dedicated to test flights only
